thebooksofmagra.com is serious about protecting your online privacy.

This Privacy Statement explains my views and practices concerning privacy and how they may pertain to you as a user of my website.

For clarification:

The terms "you" or "your" refer to you, as a participant in or as a user of any page or component of [thebooksofmagra.com](https://www.thebooksofmagra.com) website.

The terms "I", "me", "my" refer to Joël Tibbits, owner and operator of JOEL TIBBITS PRODUCTIONS.™

"My site" and "my website" mean – <https://www.thebooksofmagra.com>.

SECTION 1 – WHAT DO WE DO WITH YOUR INFORMATION?

When you browse my site, I also automatically receive your computer's internet protocol (IP) address in order to provide me with information that helps me learn about your browser and operating system so I can better improve the experience for all my users.

Email marketing: Once you have double-opted in to receive email from me and have therefore granted me your permission, I may send you emails containing information on:

- free and premium content
(i.e. PDF one-sheets and eBooks, newsletters, blog posts, video and audio files or links to these files, surveys, infographics, reports/whitepapers, etc.)
- news, updates, promotion or registration for existing or upcoming live events
- news, updates, promotion or registration for existing or upcoming online events or virtual training
- news, updates, promotion or registration for existing or upcoming launches of products or services
- news, updates, promotion or registration for existing or upcoming webinars
- news, updates, promotion or registration for existing or upcoming programs I am affiliated with
- any form of materials intended for educational or promotional purposes.

When you purchase something from my site, as part of the buying and selling process, I collect the personal information you provide such as your name, address and email address.

This enables me to both fulfill and support the products and services you purchase.

Your personal information will never be shared with unrelated third parties.

SECTION 2 – GRANTING CONSENT

To remain in compliance with the Canadian Anti-Spam Legislation (CASL) (<http://crtc.gc.ca/eng/internet/anti.htm>), you will only receive email correspondence from me (i.e. newsletter subscription and marketing or promotional messages), if you have already directly given me your expressed consent by completing a double-opt in process.

You may withdraw your consent at any time by clicking on the “unsubscribe” link which is provided at the bottom of every email I send.

You may also withdraw your consent anytime, by emailing me at info@thebooksofmagra.com or by sending a written request to: Joël Tibbits, c/o JOEL TIBBITS PRODUCTIONS 9377 127 A Street, Surrey, British-Columbia, Canada V3V 6C6.

When you provide me with your personal information to complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, I imply that you consent to my collecting it and using it for that specific purpose only.

SECTION 3 – DISCLOSURE

IMPORTANT: I do not sell, rent or otherwise disclose your personal information to any third parties, including but not limited to advertisers, strategic partners or vendors.

I take your privacy very seriously.

I may disclose your personal information if required by law to do so or if you violate our Terms of Service.

SECTION 4 – COMMITMENT TO DATA SECURITY

To protect your personal information, I take reasonable precautions and follow industry best practices to make sure it is not inappropriately lost, misused, accessed, disclosed, altered or destroyed.

SECTION 5 – THIRD-PARTY SERVICES

In general, the third-party providers I use will only collect, use and disclose your information to the extent necessary to allow them to perform the services they provide to me.

However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information I am required to provide to them for your purchase-related transactions.

For these providers, I recommend that you read their privacy policies so you can understand the manner in which your personal information will be handled by these providers.

In particular, remember that certain providers may be located in or have facilities that are located a different jurisdiction than either you or me. So if you elect to proceed with a transaction that involves the services of a third-party service provider, your information may become subject to the laws of the jurisdiction(s) in which that service provider or its facilities are located.

As an example, if you are located in Canada and your transaction is processed by a payment gateway located in the United States, then your personal information used in completing that transaction may be subject to disclosure under United States legislation, including the Patriot Act.

Once you leave my online store / website payment process or are redirected to a third-party website or application, you are no longer governed by this Privacy Policy or our website's Terms of Service.

Links: If you click on links on my online store which directs you away from my site, I am not responsible for the privacy practices of other sites and encourage you to read their privacy statements before continuing in the payment process and before making any purchases.

SECTION 6 – COOKIES

thebooksofmagra.com utilizes cookies to create a more customized experience for my users and customers. For example, I use a login cookie so members do not have to re-enter their username and password each time they return to my site. I also use tracking pixels (i.e. Google Analytics) to aid in measuring and tracking where my website traffic is coming from and to track the performance of my site.

Finally, I use remarketing pixels from Facebook and Google to aid in customized, targeted follow-up advertising.

SECTION 7 – AGE OF CONSENT

By using this site, you represent that you are at least the age of majority in your province or state of residence, or that you are at the age of majority in your province or state of residence and you have given me your consent to allow any of your minor dependents to use this site.

SECTION 8 – CHANGES TO THIS PRIVACY POLICY

I will occasionally update this Privacy Policy as necessary to protect my users and to comply with a changing environment.
